All parelists should contribute to and/or review the rationale

Dritissuedissents, crimicate what the vote was (2 to 1)

When the reason little alleged violations, the rationale should typically flow from analysis of the broadest offense to the nanovest (rather than from most severe to least severe). Include a rationale for each policy violation (if more than one).

Fisurethat the Decision maker(s) anive at the rationale independently and impartially Yur TPC and legal coursel are there as grandarils, and to ask quoting questions, but should not executive addinfuence on the outcome (assuming the TPC is not a Decision maker though they may be for dismissals or energy removal).
